

Exercise of delegated powers

The Lord Chancellor has delegated the following powers, conferred on him by the Public Records Act 1958, to the Chief Executive of The National Archives and her staff.

1. The giving of approval for the transfer of public records, in either direction, between The National Archives and places of deposit, as well as transfers between places of deposit is made under s. 4(3) of the Public Records Act 1958.

This power was exercised once during the year.
