I Henry Purcell of the City of Westminster gent being dangerously ill as to the constitution of my body but in good and perfect mind and memory thanks be to God doe by these presents publish and declare this to be my last Will and Testament And I doe here by give and bequeath unto my loving wife Frances Purcell all my Estate both real and personall of what nature so ever kind so ever to her and to her Assignes for ever And I doe hereby constitute and appoint my said loving wife my sole Executrix of this my last Will and Testament revoking all former Will or Wills whiche by my hand and seal this twentieth first day of November Anno Dni one thousand six hundred twenty five And in the seventh year of the Reigne of King William the third vs. Purcell signed sealed published and declared by the said Henry Purcell in the presence of Wm Elias John Chaplin
