CONTEXT

Administrative/Biographical history: Stan (Stanley Stephen) Awbrey (1888-1969) was born in Swansea, Glamorgan, educated at Terrace Road Boys' School, and left school at the age of thirteen to start work at a copperworks. He joined the Dock, Wharf, Riverside and General Workers' Union in 1904. and became involved in trade union activity. He became chairman of the Fuel Workers' Branch in 1913, and acted as its secretary from 1914 to 1920. In 1919, he was appointed national auditor of the Dockers' Union, and was involved in the work of the Swansea Labour Association. He was elected a delegate in 1911, and served as a member of the Executive Council from 1914 to 1926, as vice-president in 1919 and as president in 1920. He was active in local welfare and local government work and an energetic member of the House Committee of Swansea General and Eye Hospital from 1914 to 1926. Awbery became a permanent official of the Dockers' Union in 1920 on his appointment as assistant district secretary at Swansea. He played an active part in the Swansea Strike Committee of 1924. In 1926, he transferred to be district secretary at Barry Docks. His involvement with political socialism started with his work as a member of the Welsh Committee of the Independent Labour Party, of which he was elected chairman in 1929. After he moved to Barry, Glamorgan, he was elected to Barry Council in 1931, and acted as Mayor in 1941. After 1926, he was involved in both the Barry Local Labour Party and in the Divisional Labour Party, and contested the Clitheroe Division as parliamentary candidate in 1931 and 1935. He was made a Justice of the Peace for Glamorgan in 1937. He was Labour candidate for the Bristol Central Division in 1937, and returned as Member of Parliament in 1946. He had sat on the Dock Labour Decasualisation and Maintenance Committee in December 1930, and this committee produced a report for the Port Labour enquiry. During the Second World War he was appointed Port Labour Inspector for South Wales in 1940, and continued in this post until the introduction of the Docks Corporation in 1942. Awbrey's interest in trade union activity continued throughout his parliamentary career. In 1948, with F.W. Dalley, submitted a report to the Colonial Office on labour and trade union organisation in the Malay Federation. He met Dom Mintoff, leader of the Malta Labour Party, in 1958, and became involved in the efforts of the Party to

secure recognition of the trades union movement there and in the campaign for Maltese independence. Awbrey became a vocal opponent of political imprisonment in Greece, after the imprisonment in 1963 of a wartime friend Tony Ambatielos, leader of the Greek seamen, and attempted to draw the attention of the public to the assassination of Dr Lambrakis. Immediately prior to his retirement from parliament in 1964, his experience of shipping problems in the South Wales Ports coloured his spirited criticism of some proposals in the Welsh Shipping Agency Bill. After his retirement, Stan Awbrey fully developed his pastime as an amateur local historian, and became a prolific author and well-known lecturer on local history topics. He died in 1969.
