1868-1948

INTRODUCTION

The papers in this collection relate to the activities of Harry Townsend who owned a brickfield in Chelmsford Road, Copnor, in the late 1920's - early 1930's. He was responsible for building developments in the Mayfield Road/Kirby Road area of North End, and Gladys Avenue, Cowplain, in the same period. The family lived in North End in the 1920's but later moved to Oak Lodge, Longwood Avenue, Cowplain, a bungalow built by Harry Townsend. When he died in June 1931 the business was taken over by his son Harry Cecil Townsend.

The records also include an account book of W.Goddard of The Forge, Westbourne. The Goddards were relatives of the Townsend family.
