In 1909 Charles Walter Palmer set up his own plumbing and heating business in Sydenham Terrace. Soon outgrowing these premises, he moved to 17-19 Hyde Street, Southsea. C.W. Palmer's eldest son, Reginald, took over in 1930, pioneering the installation of many new types of solid and liquid fuel combustion appliances.

Palmers were well known for their welding and were the first private company in the south to commercially fit welded steel and copper systems.

Anthony Palmer joined his father's company in 1956 and two years later the firm became a private limited company. A.J. Palmer took over in 1960. Since the late 1960s C.W. Palmer & Sons has confined its operation to the commercial and industrial sectors of the market and in 1986 the company purchased a new complex at Bishop's Waltham, creating or buying a controlling interest in several other companies which now form The Anthony Group.
