Catalogue completed March 1995 AJC [Joanna Neale established the charity which bears her name on 16 June 1714 by making available the income from certain properties (and interest on certain bonds and mortgages), most or all of which she had inherited from her husband, Nehemiah Neale, for the maintenance of two elders of the Baptist Church in Berkhamsted and neighbourhood, of which she was an adherent. The endowment was for many years shared between the historically allied congregations of Berkhamsted and of Chesham in Buckinghamshire until 1877 when, after an enquiry by the Charity Commission, the Trustees from Chesham took over the invested funds of the charity and the Trustees from Berkhamsted the properties then held and £300 in consols. The properties have since been sold.
