HAMPSHIRE HOUSE (HAMMERSMITH) PARLIAMENT

Documents concerning the meetings of the Hampshire House (Hammersmith) Parliament, a political debating society, held at Hampshire House, Hog Lane, Hammersmith.

- 1907-1912, 1919-1920. Bundle of loose papers relating to the organisation of the Hampshire House (Hammersmith) 1. Parliament, which followed that of the national Parliament; negotiations for the re-formation of the Parliament in negotiations for the re-formation of the Parliament in November 1919, the first meeting being held on December 5th 1919, the Socialist Party in office; draft proposals for election of officers, negotiations for guest speakers, including a letter from the Secretary of the British Union assenting to the visit of their lecturer Captain Parsons 1920, and letter from Ernest Robinson, Socialist member of Parliament for Grimsby, declining an invitation because he was campaigning on behalf of the National Labour candidate, in a bye-election at St. Albans 1919. - 6. Undated ?c.1919. Small stiff covered volume containing "Mr. Speaker's List of Members" - an alphabetical list of members of Parliament, with the constituencies in the British Isles, and their political parties. DB/27/5
 - 1919, 1920. Three miscellaneous papers: Printed tract (no.4) urging opposition to "Tariff Reform Taxes" and support of Free Trade, 1919; typewritten letter from the secretary of Hammersmith Central Labour Party and Trading Council, addressed to "Dear Sir and brother", inviting the Hammersmith branch to send two delegates to a conference in support of the development fund of the Daily Herald newspaper to be held at 154 Goldhawk road 1919; printed copy of a notice of a special Conference of National Association for the extension of Working men's Trains and Trams, London Trades Council to protest against the abolition of Workmen's trains and the hundred per cent increase on all fares. 1920.
