#### DD/761 FULHAM HOUSING IMPROVEMENT SOCIETY LIMITED Minutes, Reports and Accounts, 1927-1968

The impetus for the improvement of housing conditions in Fulham arose out of the publication, in October 1927, of a report by Irene T Barclay and Evelyn E Perry compiled at the request of a small group of social workers connected with the Bishop Creighton Settlement and the Fulham Christian Social Council. At the instigation of the Bishop of London, a large meeting was held at Fulham Palace on 18 November 1927 at which the Fulham Housing Association (FHA) was launched.

The Fulham Housing Improvement Society (FHIS) was a public utility offspring of the FHA, becoming a registered company on 15 March 1928. Its objects were "to carry on the industry, business or trade of providing housing and any associated amenities for persons mainly of the working classes in Fulham and adjoining districts." The phrase "of the working classes" was substituted in 1963 by "of limited means upon terms appropriate to their means".

The FHIS issued shares and loan stock at a low rate of interest and with the income built new housing and re-conditioned old property which was then let at affordable rents. Properties were administered by lady managers on the principles laid down by Octavia Hill. A Committee of Management, elected annually by shareholders, met regularly, first at Bishop Creighton House, then, from December 1930, at the FHIS offices at 91 Dawes Road.

Among the early properties built by the FHIS were two blocks of flats, Rosamonds at Parsons Green, opened in 1929, and Brightwells, Clancarty Road, 1936. Individual freehold and leasehold properties were purchased for re-development and refurbishment, some of which were destroyed during the war.

In 1952 FHIS acquired a large house, Royston, 55 Putney Hill, which was opened as an Old People's Home in the following year. Although FHIS was responsible for the financial and general administration, day to day management was entrusted to a Home Committee representing the society, Bishop Creighton House and Fulham Old People's Welfare Committee, the last named being wound up in 1965. Loan and maintenance grants from the London County Council were supplemented by a public appeal. Accommodation for old people was expanded in 1963 when Wickham House, a building of twenty one flatlets, was constructed at the Kersfield Road end of the garden at Royston. Throughout the 1950s and 1960s the FHIS lost a number of its properties by Compulsory Purchase Orders. By 1966 a re-appraisal of the administration led to the conclusion that such a small society could not be run economically. Negotiations began for the amalgamation of the society's smaller properties with the Rowe Housing Trust, a process completed by 1 January 1968. A separate organisation was set up for Royston and Wickham House when the existing Old People's Home Committee constituted itself as Fulham (Royston) Housing Association.
