U61/Z4/1-202 consist of photographs found loose or in envelopes. Copies of some of these photographs appear as illustrations to the pamphlet Centenary Year (U61/Z1) and other photographs, to judge by the markings and notes made on the back, were also prepared for reproduction as illustrations in balance sheets or elsewhere.

The identification of people and branches made below in U61/Z4/1-202 were based on the illustrations in Centenary Year.

Two of the photographs, undated, are of Noah Briggs, who was appointed Secretary in 1861 and Secretary and Manager in 1867 and remained the chief official until he resigned on 12 January, 1916, a few months before his death (information supplied in Centenary Year). Most of the other photographs are also undated but appear to date from the 1920s, probably after Tower Buildings was opened in 1926, to 1961 (the date of the pamphlet Centenary Year and some to 1967.

Eccles and District Co-operative Society Ltd. (which assumed this name in 1932) and Prestwich Co-operative Society Ltd. combined with effect from 9 Sept., 1974, to form the Eccles and Prestwich Co-operative Society Ltd. For records of Prestwich Co-operative Society Ltd. and Eccles and Prestwich Co-operative Society Ltd., see respectively U61 and U159. For other items relating to the history of the Eccles and District Co-operative Society Ltd. see the J.R. Bleackley collection (U160).

The following records consist largely of items or copies circulated to Directors for meetings of the Board of Directors. Where records appear to have been specially compiled or copied for these meetings they have been catalogued as U158/AA2. Where items appear to be copies of records with uses additional to these meetings (e.g. copies of minutes, reports for members) or other kinds of enclosures, they have been otherwise catalogued (e.g. as U158/AMZ1, /A01-11). Among the enclosures are issues of publications produced by organisations in the Co-operative movement; for convenience, issues of these publications have been grouped with the later issues of these publications catalogued among the records of the Eccles and Prestwich Co-operative Society Ltd. (e.g. U159/C01/AA2, U159/Z3). Of these publications the Co-operative Gazette was particularly used for meetings of the Board. Series of the following records and publications are not necessarily complete. Many records and publications have been annotated.

The following information and list of publications have been supplied by Mr. J.B. Smethurst. Eccles Co-operative Society Ltd. was founded in 1857, its first premises being a shop in Timothy Street, Eccles (near the present Eccles Central Area Library). In 1866 it amalgamated with the Winton Co-operative Society Ltd. which had been founded in 1859-60 and which had trading premises in Worsley Road, Winton. It became the Eccles Provident Industrial Co-operative Society Ltd. It took over another

society, with premises in Pendlebury and Irlams-o'-th'-Height. In 1928 it absorbed by a transfer of engagements the Swinton Industrial Co-operative Society Ltd.; this Society had been founded in 1860 and had previously amalgamated with the Upper Swinton Co-operative Society Ltd. which had been founded in 1911. In 1929 it absorbed, again by a transfer of engagements, the Clifton Industrial Co-operative Society Ltd. which had been founded in 1858.
