The origin of the Salford Anglers Society or the Salford Friendly Anglers' Society was an early one, the date of its foundation being given as 1817 on its membership cards and some of the records catalogued below commencing in 1819. The Society was associated with a Benefit Society, as indicated in U97/AB2/1-2. The Society also acquired records of the Ramblers' Angling Society, Salford, after the end of the latter Society (see U101).

The finding of some early records of the Society is described in U97/C2-7.
