The Church of Our Father derives from a community of Dissenters who followed an ejected minister; the first meeting house was built in 1704 by the generosity of Thomas Hollis, founder of two charities, the one in Sheffield and the other in Rotherham. In 1704 the minister and congregation were termed Presbyterians; by the end of the eighteenth century Unitarianism was established there, and has continued since. The present building was named the Church of Our Father at its opening in 1808 Father at its opening in 1898.

The Church continues to be administered by the Hollis Trustees.

There are now no records of historical interest in the Church. The Registers were sent to The General Register Office. These, and other documents, were used and printed by William Blazeby in his "Rotherham Old Meeting House", Rotherham, 1906.

The records remaining are all the property, and relate to, the Hollis Trustees for the Rotherham Charity (a section of the Trust created by Thomas Hollis with separate provision for Sheffield, Rotherham and Doncaster).
