Mae'r papurau hyn wedi eu dethol fel eitemau sydd yn haeddu eu diogelu'n barhaol, ymysg casgliad helaeth o bapurau cwmni J.W. Hughes, cyfreithwyr, a ddidolwyd gan staff y Gwasanaeth Archifau. Dyddia'r casgliad o ddeugain mlynedd cyntaf y ganrif hon, ac maent yn dello'n bennaf â busnesau bach eiddo a materion personol Conwy, Penmaenmawr, a'r cylch, er bod nifer o eitemau'n ymwneud â lleoedd pellach i ffwrdd.

Dinistrwyd gweddill y casgliad ar ôl iddo gael ei ystyried o safbwynt archifol.

Cedwir yr hawl i wrthod i unrhyw un weld dogfennau yn y casgliad hwn, yn arbennig y rha! sydd o natur personol. Bydd penderfyniad Archifydd y Sir yn derfynnol ym mhob achos lle gwrthodir dangos dogfennau, heblaw fod cwmni J. W. Hughes wedi rhoi eu caniatâd nhw i'r sawl sydd yn delysfu archwilio'r dogfennau.

Rhestr dros dro yw hon: nid oes arwyddocâd i'r rhifau, nac i drefn yr eitemau yn y rhestr hon. Yn wreiddiol, trefnwyd y dogfennau yn ôl blaen-lythyren enw'r cwsmer y cyfeiria'r ffeil ato, heb unrhyw gyfeirnod pellach.

These papers have been selected for permanent preservation from a large accumulation of papers emanating from the soliciting firm of J. W. Hughes, Conwy, having been sorted by Archives Service staff. The collection dates from the first forty years of this century, and deals principally with small businesses, property transactions and personal matters in the Conwy, Penmaenmawr and surrounding areas, although a number of items relate to places further afield.

The remainder of the collection has been destroyed after archival appraisal.

The right is reserved to refuse any person permission to inspect any document in this collection, and more especially those of a personal nature. The decision to refuse permission to inspect particular documents, taken by the County Archivist, is final in all cases unless J. W. Hughes and company have specifically granted permission to the enquirer to see specified items in the collection.

This is a temporary handlist: there is no significance in the numbering scheme or arrangement of the items in this list. Originally, the documents were filed under the initial letter of the client's name without any further reference mark.
