

## NOTTINGHAM DIOCESAN ARCHIVES Personal papers of bishops

The diocesan archives are a private collection of papers. No documents later in date than May 1944 may at present be consulted and earlier documents only at the discretion of the archivist or assistant archivist. The honorary diocesan archivist and/or assistant archivist normally work in the archives one or two days a week, usually on Tuesdays and Wednesdays. No documents may be removed from the archives and any authorised photocopying done only on behalf of and at the expense of the searchers by the archivist or assistant archivist.

With the exception of some parochial registers, the archives contain very few documents prior to 1850. For earlier material application could be made to the archivist of the Archdiocese of Birmingham, c/o Cathedral House, St Chad's Queensway, Birmingham B4 6EU (see NRA 8129).

The following list of papers was compiled from information supplied by the Rev Anthony Dolan, Diocesan Archivist.
