These papers begin with a copy letter (29 Mar 1911) from M.H.C. to the Board of Agriculture & Fisheries requesting advice on regulation of commoners rights and stintage: they culminate in registration following the Commons Registration Act 1965.

They contain detailed arguments as to why claimants believe they have rights of common and in some cases (especially Castlemorton) other rights such as Estovers and Piscary.

Because of the nature of this collection many items are not listed in date order and there is some overlap between sections. For guidance read notes preceding subsections.
