Notes on records relating to Lewisham among the archives of the Worshipful Company of Leathersellers, 15 St. Helens Place, London EC3. (tel. 588 4615)

#### Examined 31 May and 7 June 1979

- Note: The bay and shelf numbers were assigned by counting from left to right round the muniment room and are not marked on the shelves.

  - 1. "Colfe MSS 1614. L.Co. 1834". Folio vol. bound in red leather, consisting 17thc. papers guarded or stuck to sheets. Some papers fragile, some unskilfully repaired, the whole in need of skilled conservation. Contents (pencilled numbers on each item/:
    - (1) Accounts of monies received from freeholders and expended "about our ground at Westwood" April 1614 - June 1615. "A note of that which hath bene given to the suite for the common of Westwood" - names and sums. 11pp. in all.

- (d) Envelope containing deeds and papers re Richard (?) Tollesbury's lands at Sydenham, including a decree declaring the manor of Sydenham to be gavelkind and list of assize rents from manor of Bellingham. Early 17th c.
- (e) Envelope containing papers re tanner's business involving Richard Valentine, Jasper Valentine and John Smith, at Southend, Lewisham: partnership agreements, apprenticeship indentures etc. c.1621.

Abraham Colfe, described as: "parcel of waste ground now enclosed containing two acres and edifices builded and yet further to be builded upon it for a Grammar School and dwelling house for the Schoolmaster and Usher etc... on the side of the Hill ascending from Lewisham to the Common of Blackheath, abutting east upon a field called Conneyberry Field, on the west upon the high road way, on the north on Blackheath and on a field full of springs adjoining the Conneyberry Field, and on the south east upon lands and a tenement belonging to the Bridge House. Acquired from Raynold Grahme, Lord of the Manor of Lewisham". The deeds listed on pp.120-127 in fact concern nos. 10-28 Lewisham Hill (formerly 1-10 Colfe Villas), described as "disposed of".

- Note: Numbers of title deeds and expired leases survive in the muniment room. They seem to be no longer boxed, but stacked on the upper shelves. Many have been damaged by damp. They were not examined in detail. The medieval deeds are still in a deed box, on another shelf.
