Licence to William Smyth, John Skenyngton and William Bolte to give and assign to the Prior and Convent of Launde three messuages, one garden, 40 acres land, 20 acres meadow, 20 acres pasture with appurtenances in East Norton and Frisby on the Wreake, Leics., extended at 36s.8d. per annum and not held from the Crown, and to the said Prior and Convent to receive and hold them, to be held to them and their heirs for ever in value of four marks a year, in part of satisfaction of 20 marks of land, tenements, rents, reversions, and services per annum. uotes letters patent, dated 6 March, 17 Edward IV, granting to Prior and Convent of Launde that they might acquire and put in mortmain lands, tenements, rents, reversions and services to the value of 20 marks a year, excepting those held in chief from the same late King, which grant he wishes to carry into effect. 20 Nov. 14 Hen. Examination of Dorothie Mylls, wife of William Mylls of Grantham, glover, taken 2 May, 1608, before William Coddington, gent., Alderman, Robert Parkins, Thomas Archer and Edw: Marrowe, gent., Justices of the Peace in the said town and soke. She received malt, but no corn from Gyll.

Examination of the wife of Thomas Mylls, and of the wife of Henry Spedye concerning same affair.

Memo. that 12 May, 6 Jas., [1608], Thomas Mylls of Grantham, shoemaker, and John Ullyott of same, shoemaker, came before three of the Justices of the town and soke and were mainpledges for William Hipworthe of Grantham, miller, that he should personally appear before them at Grantham to answer concerning certain felonies, viz., they were pledged in £40 each, and Hipworthe in £80.

Memo. that 7 May, 6 Jas., [1608], Henry Northe of Syston, tailor, Thomas Mylls of Grantham, shoemaker, and John Cxman of Grantham, blacksmith, came before three justices of the town and soke and were mainpledges for Robert Gyll of Grantham, miller, for his personal appearance at the next general sessions of the peace at Grantham etc., viz., they were pledged in £40 each, and Gyll in £80. Signatures of justices and marks of Northe, Mylls and Gyll.

- 2. Indictment. Joseph Marshall, late of South Stoke, labourer, on 6 Oct., 1618, by force of arms at South Stoke feloniously took and carried away four white ewes of the goods and chattels of John Wyllson. Endorsed: "billa vera".
